## Fund Benefits

- Funds invested in God's work, yet available if needed in the future.
- Deposits may include Cash, Securities, etc.
- Minimum deposit: \$5,000
- Additions may be made to the Fund (\$5,000 Minimum)
- Funds in whole or in part are available upon 30 days written notice.
- Amounts remaining at death go directly to CRISTA Ministries for the ministry designated.
- Agreement may be drawn to include one or two names.
- Present interest rate: 5% per annum, payable semi-annually on December 31 and June 30. (Rate may change upon 30 days notice.)
- Interest begins earning on the 1<sup>st</sup> day of the month following deposit.
- Sold only to Washington State Residents.

## Accountability

CRISTA Ministries is reviewed yearly by the Evangelical Council for Financial Accountability, an accreditation agency for Christian ministries, and is audited annually by an independent CPA firm.

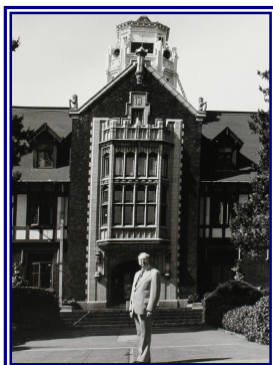
